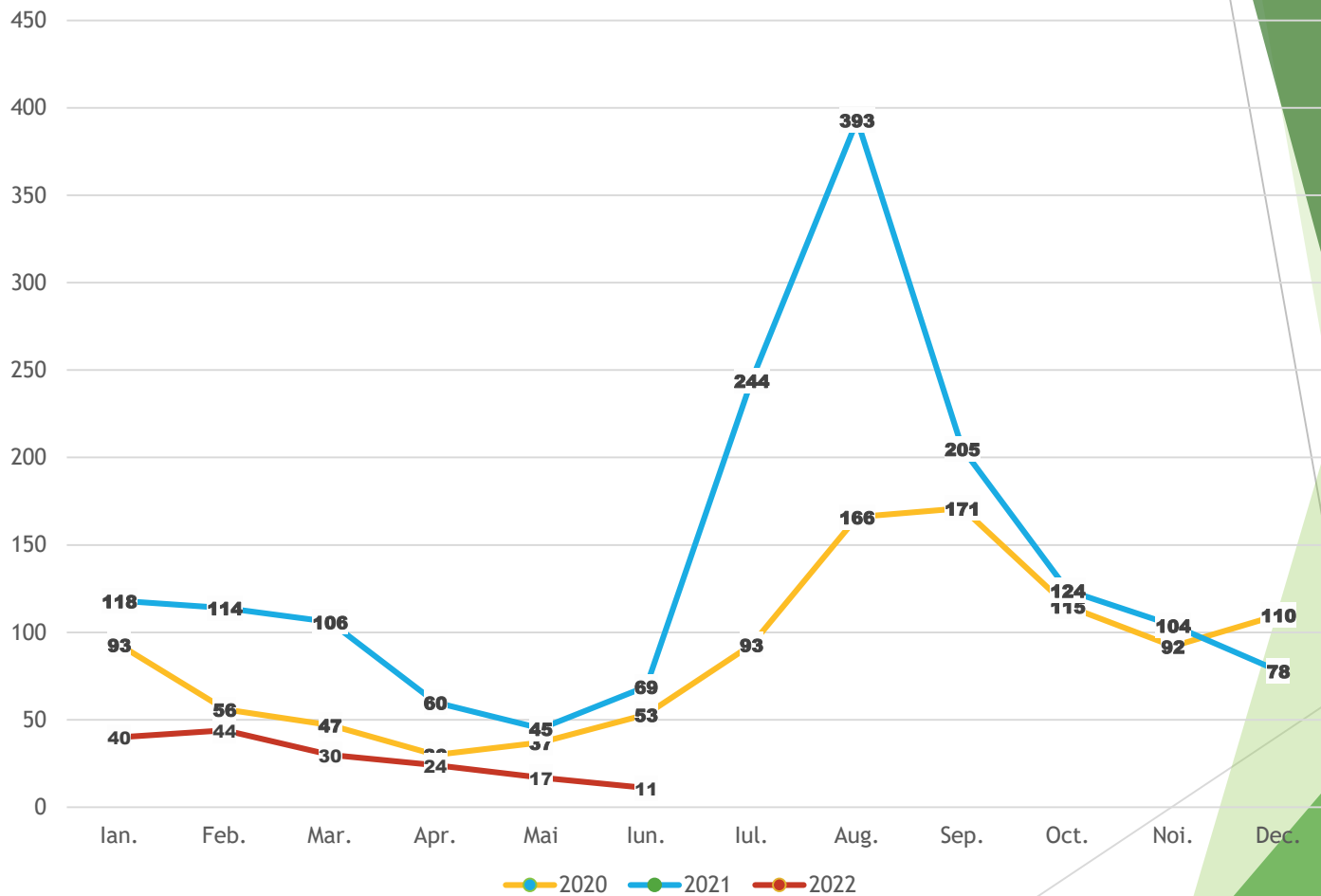

## TRAINING CAMPAIGNS

- for breeders and free practice veterinarians on symptoms, notification, obligations at suspicion,
- for official vets on epidemiological investigations

## ASF PLAN OF MEASURES

Is updated/  
supplemented within the  
Local Centers for Disease  
Control in each county

## INTENSIFIED CHECKS

- on plans, procedures and compliance with biosecurity measures for pig and poultry commercial holdings
- compliance with movement restrictions of pigs/pig products
