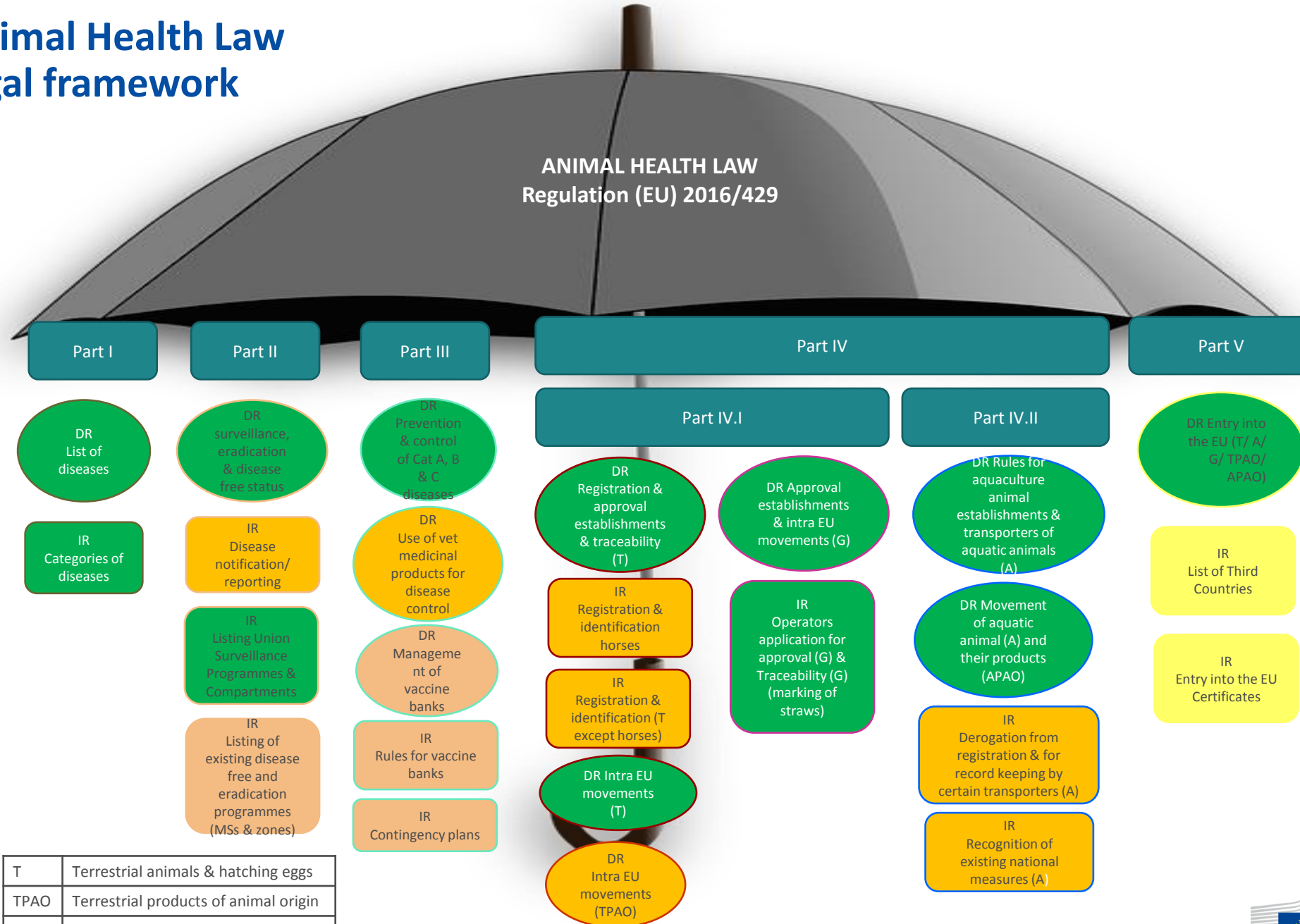
Implementing acts (3) – temporary and emergency measures

- Work ongoing:
 - Commission Implementing Regulation concerning special control measures relating to ASF
 - Commission Implementing Decision on protection measures against the fungus *Batrachochytrium salamandrivorans* (Bsal)
 - Commission Implementing Decision concerning special control measures relating to CSF
 - Commission Implementing Decision concerning certain protective measures with regard to confirmed occurrences of the small hive beetle (SHB) in Italy
- Reflection ongoing on
 - Avian influenza measures (transposing into the AHL framework Decisions 2018/1136 and 2020/47)

Work with EFSA

- Two ongoing mandates (requests for scientific opinions):
 - **Request for a scientific opinion for the listing and categorisation of transmissible animal diseases caused by bacteria resistant to antimicrobials, in the framework of the Animal Health Law**
 - **Request for a scientific opinion as regards disease control measures for category A diseases of terrestrial animals in the framework of the Animal Health Law**

Support to MSs

- Transfer of health statuses – ongoing work (*Commission Working Document SANTE/7122/2020rev1*)
- Support to MSs to facilitate transition
- BTSF training
 - Planned for 2020 and 2021 (affected by Covid 19)
