Conditions as regards bluetongue disease for authorisation of derogations for movements of kept bovine animals, kept ovine and caprine animals, kept camelids animals, kept cervid animals and other kept ungulates

Conditions for the Czech Republic with regard to infection with Bluetongue virus (BTV) in accordance with articles 13, 17(b), 24(b), 27(b) and 30(b) of Commission Delegated Regulation (EU) 2020/688 of 17 December 2019 supplementing Regulation (EU) 2016/429 of the European Parliament and of the Council.

- The Czech Republic will accept animals, that cannot fulfil at least one of the requirements laid down in points 1 to 3 of Section 1 of Chapter 2 of Part II of Annex V of Delegated Regulation (EU) 2020/689, under the following conditions in accordance with point 6 of Section 1 of Chapter 2 of Part II of Annex V to Delegated Regulation (EU) 2020/689:
 - a) the animals have been protected from vector attacks by insecticides or repellents for at least 14 days prior to the date of movement; and
 - b) they have been subjected during that period to a PCR test, with negative results, carried out on samples collected at least 14 days following the date of protection from vector attacks.

OR

2. The Czech Republic will accept animals, that cannot fulfil at least one of the requirements laid down in points 1 to 3 of Section 1 of Chapter 2 of Part II of Annex V of Delegated Regulation (EU) 2020/689, under the following conditions in accordance with point 7 of Section 1 of Chapter 2 of Part II of Annex V to Delegated Regulation (EU) 2020/689:

Member State of origin implements surveillance in compliance with the requirements laid down in Sections 1 and 2 of Chapter 1 of Part II of Annex V of Delegated Regulation (EU) 2020/689 and:

Animals under 90 days of age:

Come from a mother vaccinated against all serotypes 1-24 of BTV reported during the last two years in the Member State or zone of origin;

Animals over 90 days of age:

- a) are vaccinated against all serotypes 1-24 of BTV reported during the last two years in the Member State or zone of origin and
- b) the movement will take place at least 30 days after the first and single injection (if the vaccine used requires a single injection) or 10 days after the second injection (if the vaccine used requires 2 injections)

OR

3. The Czech Republic will accept animals, that cannot fulfil at least one of the requirements laid down in points 1 to 3 of Section 1 of Chapter 2 of Part II of Annex V of Delegated Regulation (EU) 2020/689, under the following conditions in accordance with point 5 of Section 1 of Chapter 2 of Part II of Annex V to Delegated Regulation (EU) 2020/689:

The animals have been kept in a seasonally BTV-free Member State or zone established in accordance with paragraph 3 of Article 40 to Delegated Regulation (EU) 2020/689:

- a) for at least 60 days prior to the date of movement, OR
- b) for at least 28 days prior to the date of movement and have been subjected to a serological test, with negative results, carried out on samples collected at least 28 days following the entry date of the animal into the seasonally BTV-free Member State or zone, OR
- c) for at least 14 days prior to the date of movement and have been subjected to a PCR test, with negative results, carried out on samples collected at least 14 days following the entry date of the animal into the seasonally BTV-free Member State or zone.
