



### State of play of EU legislative proposal

- On 13 March 2024, the European Parliament adopted its position on the European Commission's proposal for a regulation on waste.
- EU Parliament would:
  - raise to 40% from the Commission's 30% the food waste reduction targets at households, retail and catering
  - increase the FW reduction targets in processing and manufacturing from 10% to 20%
  - change the baseline from 2020 to an annual average between 2020 and 2022.
  - mandate the Commission to assess primary production food waste targets (including mature)
  - unharvested food or food used on farms) by 31 December 2025.
  - mandates the Commission, by 31 December 2027, to evaluate binding targets of at least 30% in processing and manufacturing and at least 50% in retail and other distribution of food, in restaurants and food services and in households to be reached by 2035
- EU Council 17 June 2024: General Approach
- Working Party On Environment, 5 September 2024: MSs supported the General Approach and generally did not support the increased FW reduction targets of EP

# Updates on the legislative proposal to amend the Waste Framework Directive

- First Trilogue Negotiation in Strasbourg 22 October 2024
- Aim: Begin negotiations on the report of the Parliament and the "general approach" of the Council, which were approved on 13 March 2024 and 17 June 2024, respectively.
- Overview: The primary focus of the negotiation will be to reach an agreement on target indicators for food waste reduction.
- **Hungarian Presidency's Proposal:** The Hungarian Presidency has suggested that 6-7 technical negotiation sessions will be required to resolve outstanding issues.
- **Urgency for Action:** The Hungarian Presidency has emphasized the importance of initiating both technical and political debates, aiming to finalize discussions by the next trilogue on 12 December 2024.

# Opening Trilogue Meeting on the modification of the Waste Framework Directive

- The EC supported the Hungarian Presidency's approach
- EP indicated that instead of the requested 6-7 technical negotiation there is only opportunity to organise only 2, and the first one will take place after the COP29 meeting (11 to 22 of November, 2024)
- The 2 technical negotiations will likely to take place: at the end of November and at the beginning of December
- Unlikely to get closed under the Hungarian Presidency period
- However, there are not many open questions left:
  - FW reduction targets
  - Edible/unedible FW categories (option to separate measurement and be used as reduction target)
