**B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.**

**Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annexes V and XIV to Implementing Regulation (EU) 2021/404 as regards the entries for Canada, the United Kingdom and the United States in the lists of third countries authorised for the entry into the Union of consignments of poultry, germinal products of poultry and fresh meat of poultry and game birds and correcting Annex XIV as regards an entry for the United Kingdom.**

The Commission presented for vote the draft amendment to Regulation (EU) 2021/404 for regionalising newly affected zones and lifting measures in zones which recovered their initial status of HPAI freedom in Canada, the UK and the US.

**Vote taken:** Favourable opinion.

**B.02 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Implementing Regulation (EU) 2021/632 as regards the lists of products of animal origin, animal by-products and composite products subject to official controls at border control posts.**

The Commission presented draft Regulation amending Regulation (EU) 2021/632 to include into the list products of animal origin, animal by-products and composite products subject to official controls at border control posts (BCPs) with their CN codes.

One Member State expressed the view that the Commission should look at Regulation (EU) 2021/630 in order to exempt certain low risk composite products from official controls at BCPs. Commission indicated that discussions are ongoing in other working groups in relation to such exemptions.

**Vote taken:** Favourable opinion.

**B.03 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending Decision 2011/163/EU and its Annex.**

The Commission presented a revised version of the draft Commission Implementing Decision amending Decision 2011/163/EU on the approval of plans submitted by third countries in accordance with Article 29 of Council Directive 96/23/EC, taking on board two Member States' comments.
