SUMMARY REPORT

A.01 Assessment of genetically modified maize MON 89034 \times 1507 \times MON 88017 x 59122 and eight sub-combinations for renewal of the authorisation, under Regulation (EC) No 1829/2003 (application EFSA- GMO-RX-027) – Presentation by EFSA.

EFSA presented the opinion on the renewal of the authorisation for the placing on the market of products containing, consisting of or produced from genetically modified maize MON $89034 \times 1507 \times MON$ 88017×59122 and eight sub-combinations.

No Member State raised questions.

A.02 Assessment of genetically modified maize MON $89034 \times 1507 \times NK603$ for renewal of the authorisation, under Regulation (EC) No 1829/2003 (application EFSA-GMO-RX-029) – Presentation by EFSA.

EFSA presented the opinion on the renewal of the authorisation for the placing on the market of products containing, consisting of or produced from genetically modified maize MON $89034 \times 1507 \times NK603$.

No Member State raised questions.

A.03 Assessment of genetically modified maize MON 94804 for food and feed uses, under Regulation (EC) No 1829/2003 (application EFSA-GMO-NL-2022-182) – Presentation by EFSA.

EFSA presented the opinion on the application for the placing on the market of products containing, consisting of or produced from genetically modified maize MON 94804.

No Member State raised questions.

A.04 Emergency measures regarding unauthorised genetically modified rice in rice products originating from China (Decision 2011/884/EU) - Follow-up discussion on reporting methodologies.

Following the discussion of the Regulatory Committee meeting of 26 April, the Commission presented the option to implement a new TRACES feature designed to assist the reporting of border controls on unauthorised GM rice in rice products from

China. The feature would facilitate reporting through TRACES instead of (manual) quarterly reports, by allowing the direct identification of consignments containing rice or rice products from China based on the requirement to upload either a Statement (for consignments that do not contain rice) or a Health Certificate and Analytical report (for consignments that do contain rice) for all consignments having CN codes listed under Annex I of 2011/884/EU.

Several Member States welcomed the initiative but requested time to allow internal discussions with competent national authorities responsible for border controls. The Commission invited Member States to conclude such discussions by the next Regulatory Committee meeting of 17 September 2024, when the Committee's agreement on the implementation of this new TRACES feature will be sought.

A.05 Assessment of genetically modified cotton COT102 for food and feed uses, under Regulation (EC) No 1829/2003 (application EFSA-GMO-DE-2017-141) – Presentation by EFSA.

EFSA presented the opinion on the application for the placing on the market of products containing, consisting of or produced from genetically modified cotton COT102.

No Member State raised questions.

A few Member States highlighted the fact that this genetically modified cotton expresses an antibiotic resistance marker gene.
