The Slovak Republic apply the first subparagraph i. e. equidae born in the Slovak Republic shall be identified in accordance with Regulation before 31 December of the year of birth of the equine animal or within six months following the date of birth, whatever date occurs later.

The Slovak Republic use of the derogation provided for in Article 12 paragraph 1. for some breeds equidae is possible to use branding as alternative methods of identification. Other alternative methods are unavailable on the present.
