In order to take account of the developments in the epidemiological situation of African swine fever in the Union, and in order to combat the risks associated with the spread of that disease in a proactive manner, new restricted zones of sufficient size should be demarcated for certain Member States and duly listed as restricted zones in Annex I to Implementing Regulation (EU) 2021/605.
