APPLICATIONS OVERVIEW**

This document has been conceived as a working document of the Commission Services. It does not represent the official position of the Commission. It does not intend to produce legally binding effects.

SUMMARY

This document provides an overview of submission deadlines and applications received for the renewal of the approval of active substances expiring between 31 March 2025 and 27 December 2028, in accordance with Commission Implementing Regulation (EU) No 2020/1740. It is foreseen that the document will be updated regularly. **It is recommended to refer to the dates of approval provided in the relevant acts adopted as published in the Official Journal (see <http://eur-lex.europa.eu>).**

Commission Implementing Regulation (EU) 2020/1740 *setting out the provisions necessary for the implementation of the renewal procedure for active substances, as provided for in Regulation (EC) No 1107/2009 of the European Parliament and of the Council concerning the placing of plant protection products on the market* applies to the substances in the AIR6 programme. In accordance with the Regulation, applications for renewal must be made at the latest 3 years before the expiry of the active substance.

Commission Implementing Regulation (EU) 2020/1093 *amending Implementing Regulation (EU) No 686/2012 allocating to Member States, for the purposes of the renewal procedure, the evaluation of active substances whose approval expires between 31 March 2025 and 27 December 2028* has been published on 24 July 2020. This Implementing Regulation allocates the evaluation of active substances whose approval expires between 31 March 2025 and 27 December 2028 a rapporteur and a co-rapporteur.
