- **8. Belgium** (9/2018) only in wild boar, no new cases since 08/2019
- **9. Slovakia** (7/2019) last ASF outbreak in pigs 8/2019
- **10. Greece** (2/2020) one outbreak in pigs
- 11. Sardinia, IT from 1978, genotype I








Main EC activities on ASF since February 2020

- 5 March: 2nd meeting of Commission's Inter-service steering group on ASF
- 21 April: remote meeting of SGE on ASF for Asia, GFTADS
- 29 April: New Annex IV to the Strategic approach: National control plans for wild boar management (thanks to all MS for comments!)
- **6 May**: remote meeting of 15th **SGE on ASF for Europe**, GFTADs
- 2-3 June: Prohibitions and Restrictions Customs Control Strategy (PARCS)
 meeting (Updated Risk information form + letter on ASF by World Customs
 Organization)
- 10 June: remote Rural Development Committee (presentation on ASF)
- 15 June: remote SGE on ASF for Americas, GFTADS
- 17 June: remote Meeting with Balkan countries and Ukraine/Moldova on ASF funding



BTSF

- 15 training sessions (from October 2020 to February 2022) in the field of Animal disease preparedness, including early warning, contingency planning and animal disease control as part of the Better Training for Safer Food initiative
- Each training focuses on a particular animal disease: ASF, Foot and Mouth Disease, Avian Influenza and Peste des Petits Ruminants



Mandates to EFSA on ASF

On-going:

 Risk of transmission by matrices, including feed (by December 2020)

New:

- Exit strategy (by January 2021)
- Outdoor farming (by January 2021)
- Epidemiological analysis (by March 2021)
- Gap research (by June 2021)
