ASF - Measures applied throughout the Czech Republic

- Whole year intensive hunting of wild boars, regardless of age category and sex, with the possibility of using some prohibited hunting methods
- Ban of wild boars feeding and restriction of baiting
- Ban on swill feeding in domestic pigs
- Ban (restriction) of imports of "trophies" from wild boars originating in countries with AMP
- Training of hunters for testing and biosecurity
- Prohibition on the use of hay and straw in pig farms from countries with AMP



ASF surveillance in the Czech Republic - Early Detection System

- in wild boar all found dead wild boar, including traffic accident to be tested for ASF (supported by the payment of CZK 2,000 (80 €) / sample).
- in domestic pigs testing in case of sudden deaths without clear cause or with suspected ASF, mass deaths, abortion

The minimum number of dead wild boars tested should be about 1% of the number hunted



ASF – situation in neighboring countries





Current measures taken - Area with intensive hunting (1 440 km²)

- Since 16. 11. 2020, the area with intensive hunting has been defined in a part of the Czech Republic (part of the regions of Ústí nad Labem and Liberec along the state border with Germany and Poland)
- The aim of this is to reduce the density of the wild boar population and risk of introduction of ASF into our territory as well
- Inside this area all found dead wild boar, including trafic accident to be tested for ASF (supported by the payment of CZK 3,000 (120 €) / sample).
 - all hunted wild boar to be tested for ASF (supported by the payment of CZK 2,000 (80 €) / sample).





Monitoring ASF within the area with intensive hunting

The intensive surveillance, including all wild boar caught in the area with intensive hunting:

- is a significant strengthening of the early detection system
- however, it also means a significant increase in the costs of monitoring ASF in the Czech Republic
