












EU PRM for 2030 to 2050






COPA-COGECA WP Seeds meeting June 14th, 2021

New Seed Law for the futhure, not for the parst

COPA/COGEAC propose a different and long-lasting EU Seed Law to meet the goals of Farm2Fork Strategy as well as **UN SDG** and consumer protection. The need to produce more food and feed requires an innovative and robust plant breeding frame and at the same time make room for other production targets than high-quality innovative seed production.
