Update on adopted and published delegated acts

- Published amendments OJ L 194 on 2/06/2021:
 - Regulation (EU) 2021/880 amending CDR (EU) 2020/686 (germinal products)
 - Regulation (EU) 2021/881 amending CDR (EU) 2020/689 (surveillance, eradication, disease freedom)
- Published amendments OJ L 274 on 13/07/2021
 - Regulation (EU) 2021/1140 amending CDR (EU) 2020/687

Delegated acts ready for adoption

- Before adoption amendments to:
 - CDR (EU) 2019/2035 (establishments and traceability)
 - CDR (EU) 2020/688 (movements of terrestrial animals),
 - CDR (EU) 2020/692 (entry into EU) two separate drafts;.
 - on composite products (doc SANTE/7132/2021) EG meeting 21/05
 - on all other commodities (doc SANTE 7186/2020) last consultation by e-mail on 30/06
- Adoption scheduled 13 and 14/072021



Recent implementing acts

- Published implementing acts:
 - CIR (EU) 2021/1070 laying down special control measures for lumpy skin disease (OJ L 230, 30.6.2021)
 - Amendments:
 - CIR (EU) 2021/1008 amending Implementing Regulation (EU) 2021/620 as regards the disease-free statuses (infection with Brucella abortus, B. melitensis and B. suis in bovine animal populations, bluetongue virus (serotypes 1-24) and infectious haematopoietic necrosis, (OJ L 222, 22.6.2021)
 - CIR (EU) 2021/1064 amending Implementing Regulation (EU) 2021/520 with regard to the animal identification code for the traceability of certain kept terrestrial animals for the United Kingdom in respect of Northern Ireland (OJ L 229, 29.6.2021)

Transitional measures for animal health/ official certificates


- Transitional measures in Regulations (EU) 2020/2235, 2020/2236 and 2021/403 for intra-EU certificates and in Regulation (EU) 2021/404
 - amended by Implementing Regulation (EU) 2021/619 amending the above regulations; published OJ L131, 16.04.2021
