The draft Commission Implementing Regulation that will be presented for discussion and opinion is the twentieth update of the list of feed and food of non-animal origin (fruits and vegetables, herbs and spices etc.) currently subject to an increased level of official controls at the borders in accordance with the provisions of Regulation (EC) No 669/2009. Article 2 of the Regulation requires the Commission to carry out a review of the list in question at least on a quarterly basis.

Decision allowing EU Member States to import additives and food supplements from China.

The reasons which led to the adoption of the Commission Decision 2002/994/EC are not applicable to those highly refined products as they do not pose problems for the presence of chloramphenicol and nitrofurantoin.

- C.01** Exchange of views of the Committee on a draft Commission Implementing Decision laying down certification rules and a model health certificate for importation into the Union of consignments of live animals and animal products from New Zealand and repealing Decision 2003/56/EC. (NG)

The draft decision updates certification rules and revises the model health certificate for import of live animals and animal products from New Zealand in order to align to the new rules laid down in the decision on the amendment of the annexes to the EU-New Zealand Veterinary Agreement (SANCO/7013/2014) which has been adopted on 18/02/2015. The current Decision 2003/56/EC will thereby be repealed.
