

- Financial support to redistribution organisations


#### **DVFA** initiatives:

- Campaign guidance and inspection






### Food waste hierachy



Food redistribution players in Denmark

- The Danish Food Bank (Fødevarebanken)
  - Wholesale
  - Covers all of Denmark
- Stop Waste Locally (Stop Spild Lokalt)
  - 25 food oases
  - Facebook groups

Small redistribution organisations, shelters etc. all over Denmark





## Working group on regulatory barriers

Dialogue and workshops with stakeholders to identify main barriers. A working group at the DVFA is looking at:

- Traceability
  - Registration in order to document forward traceability
- Hygiene regulation

- provisions on marginal, local and restricted activities, 853/2004

(exemptions for wholesale activities in retail)

- Recalls (labelling errors, risk assessments etc.)
- Labelling
  - language (not in Danish but understandable)
- Feed regulations
  - When food becomes feed complex regulation
  - Products of animal origin TSE

# Food donation campaign

DVFA launched a guidance and inspection campaign for food donations recipients in 2023:

- Duration of campaign: August October
- 50 registered food companies selected for inspection (e.g. retail food banks and homeless shelters)
- Prior to the inspection visit the companies received:
  - Information about the time of the visit (to ensure presence relevant staff)
  - A fact sheet

  Alle fødevarer skal kunne spores i alle led, så de kan trækkes tilbage, hvis der skulle
  være noget galt med dem. Det sikrer høj fødevaresikkerhed.
- Oplysninger om allergener
  Man kan gøre andre rigtig syge, hvis der ikke er styr på allergenerne. Det er derfor
  obligatorisk at oplyse om indhold af allergeneingredienser for alle fødevarer, også
- Uddannelse
  Har du medarbejdere? Så er det dit ansvar at instruere dem i korrekt behandling af
  fødevarer også selvom de arbejder frivilligt. Alle, der håndterer fødevarer, skal
  have den fornødne instruks, så de kan håndtere fødevarer på en hygiejnisk og

### Aim of the campaign - threefold

- 1. Guidance for organizations and companies receiving donations
- 2. Check regulatory compliance
  - Facilities for hygienic washing and drying of hands
  - Traceability
  - Information on allergens
- 3. Gather knowledge, more targeted inspections and guidance

### **Results**

- All inspection visits conducted.
- High regulatory compliance: 98% comply with the law.

Guidance and knowledge gathering during the inspections:


- Still a need for more guidance on some areas.
- We see potential for a new inspection campaign.







# Financial support to redistribution organisations



- Part of the Danish Strategy on Food Waste
- 2 mio. DKR ~ 267.000 € on the Finance Act (Annual budget law) in 2024
- Support for lease, rent, or purchase of a car/truck/lorry
- Up to 350.000 DKR ~ 47.000 € pr. organisation
- An order establishing the conditions is under consultation.
