**B.01** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in third countries.

(Emergency disease)

**Procedure:** Examination procedure

B.02 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation on the temporary increase of official controls and emergency measures governing the entry into the Union of certain goods from certain third countries implementing Regulations (EU) 2017/625 and (EC) No 178/2002 of the European Parliament and of the Council and repealing Commission Regulations (EC) No 669/2009, (EU) No 884/2014, (EU) 2015/175, (EU) 2017/186 and (EU) 2018/1660. (SG) This draft Commission Implementing Regulation received the Technical Agreement of the Committee, *Section Controls and Import Conditions*, in the meeting of 12-13 June 2019.

**B.03** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Implementing Regulation (EU) 2018/659 on the conditions for the entry into the Union of live equidae and of semen, ova and embryos of equidae. (AEF/EC)

The purpose of the draft is to adapt the list of third countries in order to review the regionalisation of Brazil for glanders, reinstate export of horses from Mexico, include a reference to the new denomination of North Macedonia, to further clarify the indication of the specific trade relations with Norway, allow imports of semen from Qatar, to correct the authorisation of imports of semen, ova and embryos from countries where no centre or team is approved. Suspend entry of registered horses from Kuwait following the detection of glanders. In addition, animal health certificates for entry into the Union of equidae are amended to correct the conditions for African horse sickness in case registered horses come from OIE recognised officially free countries.

In addition, certain control mechanisms will not be available until the IMSOC will be operational and therefore the obligation to notify the conversion from temporary admission to permanent entries must also be deferred to 14 December 2019.

As the new import requirements for composite products only will become applicable on 21 April 2021, the current list of such products in Commission Decision 2007/275/EC shall continue to apply until then. Hence, the list established in this draft Regulation does not cover composite products.
