B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation derogating from Union provisions on animal and public health governing the introduction of products of animal origin into the European Union as regards the introduction into the European Union of food of animal origin destined to EXPO 2015 in Milan (Italy). The draft Regulation establishes derogations for the introduction into the Union of products of animal origin destined to EXPO 2015 and measures to be applied on those products after their introduction.

The purpose of this draft Commission Decision is to approve two new rabies serology laboratories in China which passed the last proficiency test in 2014.
