Art. 95 of 'The Official Controls Regulation':

"The Commission shall, by means of implementing acts, designate European Union reference centres for animal welfare that shall support the activities of the Commission and of the Member States"



Priority areas

- 1. Welfare of broilers on farm.
- 2. Welfare of laying hens in alternative systems.
- 3. Assessment of welfare during electrical waterbath stunning for broilers and turkeys.
- 4. Assessment of welfare during transport to slaughter of broilers, turkeys and spent hens (i.e. laying hens at the end of their production cycle).
- 5. On farm killing of spent hens.

1. Coordinated assistance

- Central contact point for scientific and technical information requested by Competent Authorities of MSs (e.g. 'Questions to the Centre')
- Networking across supporting bodies, CA's and policy workers in MSs
 - Existing networks
 - National ref centres
- Development of the work programme 2021-2022













2. Animal welfare indictors

- For the 3 first priority areas in 2020
 - Compiling a list of legal requirements to check during officials controls
 - Identify relevant welfare indicators to verify compliance with the legal requirements identified
 - Propose validated indicators and methods for assessment













3. Scientific and technical studies

- To provide scientific and technical expertise on the official controls and the implementation of the legislation related to poultry.
- To identify the gaps of knowledge and the bottlenecks regarding legislation and formulate different topics for scientific and technical studies.
- To develop in the framework of the Centre, some scientific studies designed to answer questions raised in activity 2.













4. Training and education

 To review and assess the existing training courses and materials in use at BTSF, member state or other levels (e.g. national and regional training courses)
