Under the EU Farm to Fork Strategy, the Commission has committed to revise the EU animal welfare legislation by 2023. The objective is to ensure a higher level of animal welfare by aligning the current rules with the latest scientific evidence, broadening their scope and making them easier to enforce, as well as to contribute to the achievement of a more sustainable food system.

As a first step towards the revision, the Commission has undertaken an evaluation ("Fitness Check") of the current EU animal welfare legislation, with the aim to assess whether it is still fit for purpose, in particular the extent to which the rules are relevant, efficient, effective, coherent, and have an added value. This exercise is now concluded, and its results are presented in a Commission Staff Working Document.

Commission Delegated Regulation (EU) 2021/2156 (OJ L 436, 7.12.2021, p. 26) established the European Union reference laboratory (EURL) for Rift valley fever (RVF). Following the establishment of this EURL and in accordance with point (a) of Article 93(2) of Regulation (EU) 2017/625, the Commission followed a public selection process for the designation of the EURL for Rift valley fever. The proposed Implementing Regulation designates a European Union reference laboratory EURL RVF. It lays down the name and contact details of the selected EURL. A public selection process preceded the designation of this EURL.
