Article 2 of the Regulation requires the Commission to carry out a review of the list in question at least on a quarterly basis. The proposal introduces the following changes: new listing of aubergines, Chinese celery and yardlong beans from Cambodia (food), sesamum seeds from India (food) and dragon fruit from Viet Nam (food); de-listing of frozen strawberries and pomelos from China.
