1. LEGAL BASIS

Regulation (EU) No 652/2014 of the European Parliament and of the Council of 15 May 2014 laying down provisions for the management of expenditure relating to the food chain, animal health and animal welfare, and relating to plant health and plant reproductive material¹, in particular Title II, Chapter II, Section 2 thereof.

2. BUDGET LINE

The maximum Union contribution for the implementation of survey programmes for pests for 2017 and 2018 is hereby set at EUR 40 000 000 and shall be financed from the appropriations entered in the following line of the the general budget of the European Union for 2017-2018 – budget line 17.04.02:

EUR 15 000 000 for 2017;

EUR 25 000 000 for 2018.

3. Priorities for 2017-2018

The second paragraph of Annex III to Regulation (EU) No 652/2014 sets out priorities for Union financial support, as regards the orientation of national programmes for pest surveys for the protection of the Union teritory. Based on that Annex, the following priorities for 2017-2018 have been laid down:

- (a) The pests listed in Section I of Part A of Annex I and Section I of Part A of Annex II to Directive 2000/29/EC as not known to occur in the Union territory ('not known to occur listed pests'), to which an indicative 30 % of the available commitment appropriations on budget line 17 04 02 shall be dedicated.
 - i. pests of fruit trees and plants:
 - *Aleurocantus spp.*
 - *Citrus tristeza virus* (non-European strains)
 - Diaporthe vaccinii Shear
 - The following non-European Tephritidae
 - Dacus dorsalis (Hendel)
 - Pterandrus rosa Karsch
 - Rhagoletis fausta (Osten-Sacken)
 - Phyllosticta citricarpa (McAlpine) Van der Aa
 - Toxoptera citrida
 - *Xanthomonas campestris* (all strains pathogenic to Citrus)
 - Candidatus Liberibacter spp. causal agent of Huanglongbing disease of citrus or "citrus greening disease", and its vectors (Diaphorina citri Kuway and Trioza erytreae Del Guercio)

- (d) The pests which represent an emerging risk for the Union territory, to which an indicative 10 % of the available commitment appropriations on budget line 17 04 02 will be dedicated. The priority pests include the following:

4. OBJECTIVES PURSUED

The objectives of the survey programmes shall be the following:

- (a) The **general** objective is to contribute to a high level of health for plants along the food chain and in related areas, by preventing and eradicating pests and by ensuring a high level of protection for consumers and the environment, while enhancing the competitiveness of the Union food and feed industry and favouring the creation of jobs.
- (b) The **specific** objective is to contribute to the timely detection of pests in the Union territory.
- (c) The **operational** objectives shall be the following:
 - (i) to timely identify and detect emerging risks as regards non listed pests which represent an imminent or potential danger for the EU territory;
 - (ii) to ensure the early and appropriate action against the presence of pests, in particular:
 - the non-listed pests representing an imminent danger for the Union territory,
 - the "not known to occur" listed pests,
 - the pests subject to measures adopted by the Commission in accordance with Article 16(3) of Directive 2000/29/EC, and
 - the potato pests subject to the measures laid down in Directives 69/464/EEC¹⁴, 93/85/EEC¹⁵, 98/57/EC¹⁶ and 2007/33/EC¹⁷;
 - (iii) to improve the functioning of the Union plant health legislation by monitoring the risks of pests listed in Directive 2000/29/EC and pests not

listed in the previously mentioned Directive, after interceptions of imported commodities infested with these pests.

5. EXPECTED RESULTS OF THE SURVEY PROGRAMMES

The expected results of the survey programmes shall be the following:

- (a) Aggregated data (maps) on the absence or the presence of the following:
 - (i) the pests listed under point 3 of the present Annex;
 - (ii) the pests subject to measures adopted by the Commission in accordance with Article 16(3) of Directive 2000/29/EC on specified crops, trees and the environment, including data on their distribution in the Union territory;
 - (iii) the potato pests subject to the measures laid down in Directives 69/464/EEC, 93/85/EEC, 98/57/EC and 2007/33/EC.
- (b) An inventory of the non-listed pests which curently represent imminent danger for the Union territory.
- (c) Aggregated data on the risks associated with specific types of imports.

6. ELIGIBILITY AND AWARD CRITERIA

The survey programmes shall be implemented under the sole responsibility of the competent authorities of the Member States.

As provided for in Article 3(2) of Regulation (EU) No 652/2014, when grants are awarded to the competent authorities of the Member States, they shall be considered to be identified beneficiaries within the meaning of Article 128(1) of Regulation (EU, Euratom) No 966/2012.

Therefore, such grants may be awarded without a call for proposals.

6.1. Eligibility criteria for submitted survey programmes

- (a) Programmes must be submitted to the Commission by the single authority of the Member States, referred to in the first subparagraph of Article 1.(4) of Directive 2000/29/EC, which shall also be responsible for supervising and coordinating their implementation.
- (b) Only survey programmes for which the implementation is under the responsibility of the competent authorities of the Member States may receive a Union financial contribution.
- (c) Compliance of the submitted programme with the requirements of Union plant health legislation / rules;
- (d) Survey programmes must be submitted by 31 May 2016 in accordance with Article 21(1) of Regulation (EU) No 652/2014.
- (e) Survey programmes must comply with Articles 19 and 21 of Regulation (EU) No 652/2014.
- (f) To be eligible for co-funding, the survey programme must include at least the priorities referred to in points (a) and (b) of Section 3. If an organism from priority areas laid down under (a) or (b) is not included in the survey

programme, a motivation should be provided by the Member State and accepted by the Commission.

6.2. Award criteria for survey programmes submitted to the Commission

Award criteria make it possible to approve programmes that can guarantee compliance with Union objectives and priorities. To this end, each programme presented with a view to obtaining Union co-financing will be individually evaluated based on the following criteria:

- (a) the consistency of the survey programme with the objectives listed in Section 4 and expected results listed in Section 5;
- (b) the overall quality of the survey programme, namely, the relevance of the planned activities (type of actions proposed and the quantities of actions), taking into account the specific situation at national level;
- (c) the cost efficiency of the survey programme, including management costs.

7. INDICATIVE TIMETABLE OF THE GRANTS

January 2017 for surveys to be implemented in 2017 and January 2018 for surveys to be implemented in 2018.

8. MAXIMUM POSSIBLE RATE OF CO-FINANCING OF THE ELIGIBLE COSTS

According to Article 5(1) of Regulation (EU) No 652/2014, the general rate for grants shall not exceed **50%** of the eligible costs. Nevertheless higher co-financing rates could be justified for different eligible measures, taking into account the characteristics of the pests or the situation of the concerned Member State/s.

In accordance with Article 5(2) of Regulation (EU) No 652/2014, the maximum rate of 50% may be increased to 75% of the eligible costs in respect of:

- (a) Cross-border activities implemented together by two or more Member States in order to control, prevent or eradicate pests.
 - The potential application of point (a) will depend on the survey programme submitted to the Commission. The survey programme must clearly describe the co-operation between the Member States, as provided for in Article 5(2)(a) of Regulation (EU) No 652/2014.
- (b) Member States whose gross national income per inhabitant based on the latest Eurostat data is less than 90% of the Union average, as provided for in Article 5(2)(b) of Regulation (EU) No 652/2014.
 - The potentially eligible Member States under point (b) are currently: Bulgaria, the Czech Republic, Estonia, Greece, Croatia, Cyprus, Latvia, Lithuania, Hungary, Malta, Poland, Portugal, Romania, Slovenia and Slovakia.

9. ELIGIBLE COSTS

In accordance with Article 20 of Regulation (EU) No 652/2014, the following costs incurred by the Member States in implementing the survey programmes may qualify for grants:

(a) the costs for sampling;

- (b) the costs of tests, provided that they are limited to:
 - (i) the costs of test kits, of reagents and of consumables which are identifiable and specifically used for carrying out the tests;
 - (ii) the costs of personnel, regardless of their status, directly involved in carrying out the tests;
- (c) in exceptional and duly justified cases, the costs incurred in carrying out necessary measures, which have been requested by the Member States with the appropriate justification in the grant application and accepted by the Commission.
