- **Commission Decision of 24 January 2017** establishing the Commission Expert Group 'Platform on Animal Welfare'
- March 2017: Call for applications
- Motto: "Everyone is responsible "





# **Composition, tasks and meetings**

- Participants: 75 members of the Platform
  - Member States, NGOs, business and professional organisations, scientific independent experts
- Tasks:
  - Better enforcement of EU animal welfare legislation
  - Development of voluntary commitments
  - Promotion of EU standards globally
- Meetings: 6 June and 10 November 2017; 21 June 2018





### **First session "Enforcement"**

- Outcomes of the 1<sup>st</sup> meeting of the subgroup on transport working in 3 working groups:
- Extreme temperatures/weather conditions
- Export of cattle
- Transport of unweaned animals
  <u>17 October 2018: second meeting</u>
- Establishment of subgroups on the welfare of pigs
- Main goal of its work: to reduce the risk of tail-biting
  <u>26 November 2018: first meeting</u>





## **Second session "Voluntary initiatives"**

### • Welfare of farmed fish presented from:

- State perspective: Norway
- Industry perspective: Federation of European Aquaculture Producers (FEAP)
- Animal welfare organisation perspective: Eurogroup for animals
- Requests for the creation of subgroup on fish and of voluntary initiative on pullets


