Expert Group on Regulation (EU) 2016/429 -

to discuss delegated acts supplementing Animal Health Law and amending Delegated Regulations (EU) 2020/686 and 2020/692 as regards germinal products - E00930

- 2. Exchange of views as regards possible amendments to Commission Delegated Regulation (EU) 2020/686¹ supplementing Regulation (EU) 2016/429 in relation to animal health requirements for movement between Member States of germinal products, and in particular as regards:
 - 2.1. Processing and storage of semen at a semen collection centre different from the semen collection centre of its collection.
 - 2.2. Testing of boars for PRRS.
 - 2.3. Semen of equine animals: antibiotics or mixtures of antibiotics added to semen or contained in semen diluents.
 - 2.4. Requirements as regards infection with epizootic haemorrhagic disease virus (EHD).
 - 2.5. Annex I to Delegated Regulation (EU) 2020/686.
 - 2.6. Age of animals used for semen collection.
- 3. Exchange of views as regards possible amendments to Commission Delegated Regulation (EU) 2020/692² supplementing Regulation (EU) 2016/429 in relation to animal health requirements for entry into the Union of germinal products, and in particular as regards:
 - 3.1. Animal health requirements for semen used for *in vitro* production of bovine embryos intended for entry into the Union.
 - 3.2. Residency periods for semen donor bovine animals.
 - 3.3. Animal health requirements for entry into the Union of germinal products of dogs, cats, camelid and cervid animals.

Commission Delegated Regulation (EU) 2020/686 of 17 December 2019 supplementing Regulation (EU) 2016/429 of the European Parliament and of the Council as regards the approval of germinal product establishments and the traceability and animal health requirements for movements within the Union of germinal products of certain kept terrestrial animals (OJ L 174, 3.6.2020, p. 1).

- 3.5. Requirements as regards foot and mouth disease for entry into the Union of *in vivo* and *in vitro* embryos of bovine, ovine, caprine and porcine animals.
