Outcome of the budget reallocation procedure for 2022

The initial budget allocation for the 2022 veterinary programmes was 104.268.000€

The budget reallocation 2022 is 94.162.000€



Outcome of the budget reallocation procedure for 2022

All reallocation requests submitted by the Member States and Third Countries have been accepted (except for bovine tuberculosis due to the budget phasing-out process applied for this disease / initial allocation has been kept)

The decrease of the budget requested by the Member States is mainly due to Rabies (less vaccinations than initially foreseen) and to Salmonella (less vaccinations and less positive cases than initially forecasted)
