

Results of the implementation of ASF control program in Latvia in 2015

ASF in wild boars and pig farms - summary at the end of 2014

and restriction territories according to Decision 2014/709/EU



ASF surveillance and control in Latvia (2015)

Domestic pigs

- Passive surveillance in all territory
- Inspection by FVS: 1-2 checks for each farm in 2015 (all territory but ASF restricted areas as priority)

Wild boars

- Passive surveillance in all territory
- Sampling of all hunted / found dead wild boars in Part II and Part III
- Target hunting of wild boars (only adult and sub-adult females)

ASF summary

2014

First outbreak – 26.06.2014.


- **Domestic pigs 32** outbreaks
- Destroyed 564 pigs

- Wild boars 217 (178 found dead; 39 hunted)
- Affected 13 counties (including 34 parishes)

2015

- Domestic pigs 10 outbreaks
- Destroyed 213 pigs
- Wild boars 1048 (626 found dead; 422 hunted)
- Affected 52 counties (including 184 parishes)

ASF <u>CASES</u> in wild boars and <u>OUTBREAKS</u> in pig farms (2015)



ASF surveillance in wild boars (2015)

Tested to ASF:

Total - 13 179


- Dead 847
- Hunted 12 332

Positive to ASF:

Total - 1048

- Dead 626
- Hunted 422 (including 204 seropositives)

ASF IN WILD BOARS (2015)



Target hunting to reduce the WB(s) population

- Target hunting practices selecting adult and subadult <u>females</u>
- Applying to the whole territory of Latvia
- Initiated in 20 November, 2015
- 100 EUR paid for each adult and sub-adult female of WB
- Reaching a wild boars density of 0,5 wild boar/km² or lower is expected to reduce the spread of ASF

Inspections to verify biosecurity measures in place (2015)

- The total number of pig farms 6857
- Inspections carried out 7632

Results:

- Biosecurity measures <u>are in place</u> (77%)
- Biosecurity measures <u>have to be</u> <u>improved</u> – (23%)
