C.01 Exchange of views of the Committee on a draft Commission Implementing Regulation laying down implementing measures for the Rapid alert system for food and feed, and rules as regards the computerised information system for notifying and reporting on listed animal diseases, the notification of the presence of, and protective measures taken against, plant pests, administrative assistance and cooperation between Member States' authorities, and the functioning of the information management system for official controls ('the IMSOC Regulation'). (HK)

The purpose of the draft is to define the system components of the IMSOC (iRASFF, ADIS, EUROPHYT and TRACES) and to lay down common rules for the functioning of all those system components in relation to data protection, ownership and publication of information, connection with national information systems and third countries and international organisations, and duties of the Commission as regards the IMSOC. The draft also lays down specific rules for the functioning of each system component, including contingency arrangements.
