Delegated Regulation (EU) 2020/687

Commission Delegated Regulation (EU) 2023/751

- amended Delegated Regulation (EU) 2020/687
- published in the OJ of the EU on 20 February 2023
- in force since 12 March 2023

Amendments (1)



Article 21 – Establishment of a restricted zone

Enabling competent authority to **derogate from establishing restricted zone for outbreaks** of HPAI and ND in establishments

- keeping **up to 50 captive birds**
- have no direct or indirect contact with poultry or other captive birds

Amendments (2)

Articles 28 and 43 - General conditions to grant derogations

Designation of establishment of destination for movements from or to protection/surveillance zone

by cooperation between competent authorities of **origin and destination**



Amendments (3)



Articles 30 and 46 - Movements of ready-to-lay poultry from protection/surveillance zones

add **possibility to move in an epidemiological unit** where there is no other bird

Amendments (4)



Articles 39 and 55 – Duration of disease control measures

Clarify the starting point of counting the minimum period to maintain the disease control measures in protection and surveillance zone, as

day following the date of completion of preliminary cleaning and disinfection

Amendments (5)

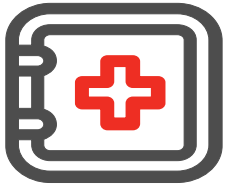


Article 46 (1) – Movements of day-old chicks

Adding possibility to move DOC from establishments in the **surveillance zone if they**

were hatched from eggs **originating** from establishments **within the restricted zone**

Amendments (6)



Annex VII – Risk mitigating treatments for products of animal origin

Enabling **new treatment of meat for ASF**

- heat treatment to achieve a core temperature of 70 °C for at least 30 minutes

Enabling **treatments for** sheep pox and goat pox (**SPGP**), as the ones for LSD

- for meat: removal of offal
- for milk: pasteurization

Corrections

- **Definition of casings:** aligned with the one in Delegated Regulation (EU) 2020/692)
- **Annex VI,** prohibitions for movements of:
 - **hatching eggs:***to and from establishments in the restricted zone*),
 - **feed material** of plant origins: *Movements of feed materials of plant origin and straw obtained in the **restricted** zone*
- **Title of Annex VIII:** *RISK-MITIGATING TREATMENTS FOR PRODUCTS NOT OF ANIMAL ORIGIN FROM THE **RESTRICTED** ZONE*

Future amendments

EFSA scientific opinions (SO) published during 2021 and 2022:

- 15 SO on assessment of control measures for all category A diseases
- SO for prohibitions in restricted zones and risk-mitigating treatments for products of animal origin and other materials

Amendments, if needed, for Annexes of Delegated Regulation (EU) 2020/687 for:

- Sampling procedures in restricted zones
- Monitoring period
- Minimum radius
- Minimum duration
- Prohibitions and risk mitigation treatments
