The changing epidemiological situation of certain diseases makes it necessary to list in the Annexes to Commission Implementing Regulation (EU) 2021/620 new disease-free Member States or zones thereof, to de-list areas where the conditions for maintaining the disease-free status are no longer met, and to approve compliant compulsory or optional eradication programmes submitted to the Commission.
