The draft Implementing Regulation amends model certificates and model declarations for the entry into the Union of consignments of certain categories of terrestrial animal and germinal products thereof in order to, i.e.: reflect new animal health requirements introduced to Commission Delegated Regulations (EU) 2020/692 by Delegated Regulation (EU) 2023/119, and (EU) 2020/688 by Delegated Regulation (EU) 2023/647; update references to new legislation regarding residues requirements for the entry into the Union of animals, and clarify and make consistent the wording of certain requirements, notes and footnotes.
