B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Implementing Regulation (EU) 2020/2235 of 16 December 2020 laying down rules for the application of Regulations (EU) 2016/429 and (EU) 2017/625 of the European Parliament and of the Council as regards model animal health certificates, model official certificates and model animal health/official certificates, for the entry into the Union and movements within the Union of consignments of certain categories of animals and goods, official certification regarding such certificates and repealing Regulation (EC) No 599/2004, Implementing Regulations (EU) No 636/2014 and (EU) 2019/628, Directive 98/68/EC and Decisions 2000/572/EC, 2003/779/EC and 2007/240/EC (PHS)

The main objective is to amend Annexes III and IV to Implementing Regulation (EU) 2020/2235 lays down, inter alia, model certificates for the entry into the Union of consignments of certain highly refined products of animal origin and for certain movements of animals to be used in the case of ante-mortem inspection at the holding of provenance or in the case of emergency slaughter outside the slaughterhouse.

C.01 Exchange of views of the Committee on a draft Commission Regulation amending Regulation (EC) No 2073/2005 on microbiological criteria for foodstuffs as regards *Listeria monocytogenes* (MP)

The purpose of this initiative is to ensure a higher level of consumer protection against *Listeria monocytogenes* by amending Annex I to Regulation (EC) No 2073/2005 as regards the stage of the food chain where food safety criterion 1.2 applies.

C.02 Exchange of views of the Committee on a draft Commission Implementing Regulation laying down laboratory analytical methods applicable to the official controls performed for the verification of compliance with provisions laid down in Commission Regulation (EC) No 2073/2005 (MP)

The purpose of this initiative is to improve the reliability and consistency of official controls by establishing Union rules regarding analytical methods to be used by the official laboratories when they analyse official samples against criteria laid down in Regulation (EC) No 2073/2005.
