B.01 Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Annex I to Regulation (EC) No 669/2009 implementing Regulation (EC) No 882/2004 as regards the increased level of official controls on imports of certain feed and food of non animal origin (GB)

The draft Commission Implementing Regulation that will be presented for discussion and opinion is the eighteenth update of the list of feed and food of non-animal origin (fruits and vegetables, herbs and spices etc.) currently subject to an increased level of official controls at the borders in accordance with the provisions of Regulation (EC) No 669/2009. Article 2 of the Regulation requires the Commission to carry out a review of the list in question at least on a quarterly basis.

- B.02** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation amending Regulation (EU) No 750/2014 on protection measures in relation to porcine epidemic diarrhoea as regards the animal health requirements for the introduction into the Union of porcine animals (PB)

The draft prolongs the application of Regulation 750/2014 (which applies until 12 January 2015) until 30 October 2015.

- B.03** Exchange of views and possible opinion of the Committee on the Commission Implementing Regulation amending the public health requirements for residues in the import model health certificates for meat preparations, meat products and treated stomachs, bladders and intestines as well as fresh meat of solipeds set out in Decisions 2000/572/EC and 2007/777/EC and Regulation (EU) No 206/2010 (PB/AEF)

The draft amends the declarations in the requirements provided for in Directives 96/22/EC and 96/23/EC in the import health certificates for fresh meat, meat preparations and meat products, and treated stomachs, bladders and intestines made of or containing meat from domestic solipeds and introduces a minimum residency period in the third country for food producing solipeds.
