#### Article 111 of Regulation (EU) 2016/429

## "Each competent authority shall inform the Commission of, and make publicly available, information on:"

- contact points for the computer databases
- the authorities or bodies responsible for issuing identification documents, movement documents and other documents
- the means of identification that are to be used for each species and category of kept terrestrial animals
- the prescribed format for the issuing of the identification documents and other documents referred to in Article 110.
- Species: Bov, Ov/cap, Por, Eq



## Delegated Regulation (EU) 2019/2035

"Each competent authority shall inform the Commission of, and make publicly available, information on:"

- list of breeds of bovine animals reared specifically for traditional cultural and sporting events
- list of establishments of a specific supply chain (porcine animals)
- populations of kept equine animals living under semi-wild conditions and the areas where they live
- the means of identification to be used for camelid and cervid animals.



## Implementing Regulation (EU) 2020/963

"Member States shall [make information] ... available to the Commission, the other Member States and the public on a website established by the competent authority."

"...the Commission shall establish a website to which each Member State shall provide a direct link to the required information"

- a list of competent authorities and, where applicable, delegated bodies, responsible for issuing single lifetime identification documents for equine animals
- authorised alternative methods of identification for equine animals
- contact point to receive the attestation referred to in point (c)(i) of Article 27(1) or the identification documents referred to in point (c)(ii) of Article 27(1) for further distribution to the respective issuing body

- Ovine/caprine: Country Information (europa.eu)
- Equine: Country Information (europa.eu)
- Problems:
  - Missing and/or outdated information
  - Mixture of documents and links
  - Broken links
  - Missing species: porcine, camelid, cervid

- General ID and R umbrella page with general information: <u>Identification</u> (<u>europa.eu</u>)
- Sections for national information and for species-specific rules
