(IC)

This Regulation lays down rules for the uniform application of Articles 88 and 89 of Regulation (EU) 2017/625 as regards issuance and replacement of the animal health certificates and official certificates provided for in Regulations (EU) No 2016/429 and 2017/625 for the entry into the Union and movements within the Union of certain consignments of animals and goods. This Regulation establishes models of certificates for movements between Member States, with in the Union, for the entry

into the Union animals and goods and establishes certificates and attestation for the certain categories animals and goods intended for human consumption.

- B.03** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Regulation laying down rules for the application of Regulations (EU) Nos 2016/429 and 2017/625 of the European Parliament and of the Council as regards model animal health certificates for the entry into the Union and movements within the Union of consignments of aquatic animals and of certain products of animal origin from aquatic animals. (IC)

This Regulation lays down rules for the uniform application of Articles 88 and 89 of Regulation (EU) 2017/625 as regards issuance and replacement of the animal health certificates provided for in Regulation (EU) No 2016/429 and establishes model animal health certificates and a model declaration for the entry into the Union and movements within the Union of certain consignments of aquatic animals and of products of animal origin from aquatic animals.

Section C **Draft(s) presented for discussion**

- C.01** Exchange of views of the Committee on a draft Commission Implementing Regulation laying down the lists of third countries, territories or parts thereof from which the entry into the Union of animals, germinal products, products of animal origin is permitted in accordance with Regulation (EU) 2016/429 of the European Parliament and of the Council. (CMB)

Regulation (EU) 2016/429 lays down, inter alia, the animal health requirements for the entry into the Union of animals, germinal products and products of animal origin. One of those requirements is that animals, germinal products and products of animal origin come from a third country or territory listed in accordance with Article 230(1) of that Regulation, or from a zone or compartment thereof. This draft Commission Implementing Regulation lays down the lists of third countries, territories or parts thereof from which the entry into the Union of animals, germinal products and products of animal origin is permitted in accordance with the requirements laid down in Regulation (EU) 2016/429 and Commission Delegated Regulation (EU) 2020/692.
