The rapporteur presented the report “The welfare of animals during transport”. It was agreed to circulate the report in his Rev 9, to all members of SCAH in order to introduce as soon as possible amendments and possible inputs specially on chapter 3 and 4 in this early stage of the report. The report will be presented for discussion at the next SCAHAW Plenary meeting on 12-13 December. The rapporteur will submit a revised version at the next SCAW meeting the 24 January for approval.
