

Main Activities

(Art. 96 of the Official Controls Regulation)

- 1. COORDINATED ASSISTANCE
- 2. ANIMAL WELFARE INDICATORS
- 3. SCIENTIFIC AND TECHNICAL STUDIES
- 4. TRAINING COURSES
- 5. DISSEMINATING RESEARCH AND INNOVATIONS





Main activities

Will cover:

- 'aquaculture animals'
 - at all its life stages, reared in a farm,
 - including any aquatic animal from the wild intended for a farm.
- the entire production chain from farming, transport to slaughter/killing.







Tasks

- Will support Member States and the Commission with technical expertise related to the welfare of aquatic animals.
 - developing methods for the assessment and improvement of welfare of animals;
 - carrying out scientific and technical studies;
 - conducting training courses for competent authorities and national supporting bodies;
 - disseminating research findings and technical innovations.
- Will help in developing animal-based indicators for a better monitoring of welfare of aquatic animals.
- Focus on the enforcement of EU rules to assist the competent authorities in performing better official controls.







Work programme of the Centre

 The specific tasks of the Centre will be defined in the annual or multiannual work programmes established in conformity with the objectives and priorities of the relevant work programmes adopted by the Commission





Next steps

The designation should be reviewed every seven years, starting from the day of application of the Decision (1 February 2024)
