### **2. Historical data on the epidemiological evolution of the disease(s)<sup>4</sup>:**

The bovine brucellosis eradication program is applied on the area controlled by the Veterinary Services of the Republic of Cyprus. The total bovine population is estimated to 55,035 animals, reared in 355 herds. The bovine population under the brucellosis eradication program is 38,366 animals in 328 herds.


According to the epidemiological data, from 2000 until April 2010, the prevalence and incidence of bovine brucellosis in Cyprus have decreased and reached zero level (see Graph 1).

From 1/1/2002 until October 2004, United Nations Office for Project Services has funded the bicontrural bovine brucellosis eradication program (UNOPS, Cont. No: WSI-PS03-4463). In 2004, 2005, 2006, 2007, 2008 and 2009 the EU has cofinanced the 50% of the programme.

#### Description of the submitted programme<sup>5</sup>:

The bovine brucellosis eradication program is based on a test and extended slaughter or killing of positive animals, implemented in the area controlled by the Veterinary Services of the Republic of Cyprus, concerning all bovine animals over 12 months old. Also, there is a program of declaration of farms as brucellosis officially free. Until now 254 farms have been declared officially free. The rest herds are under the procedure of granting the officially free status. According to the article 7 of the L.O.14/2002 treatment of infected animals with brucellosis and the use of vaccines are prohibited. As a positive case is defined a case when an animal reacts positively at Rose Bengal test and CFT test (> 20 ICFTU).

##### *4.2. Organisation, supervision and role of all stakeholders<sup>6</sup> involved in the programme:*

The Department of Veterinary Services, which belongs to the Ministry of Agriculture, Environment and Natural Resources, is responsible for the application of the bovine brucellosis eradication program. The Director of the Veterinary Services is responsible for the coordination of the whole program.

The five District Veterinary Offices with six District Veterinary Stations are responsible for the collection and the transport of the samples to the Laboratories, the information of the owners for the results, the epidemiological report in new outbreaks, the slaughter of the seropositive animals and the compensations and the disinfections of the infected farms.

The 3 District Veterinary Laboratories under the supervision of the Central Laboratory are performing the RB test for samples coming from their area. The Central Veterinary Laboratory performs the RB test for one District. All RB positive samples are further processed in the Central Laboratory with CFT. The bulk milk ELISA test is performed in the Central Laboratory.



The Laboratories report all the results to the District Veterinary Offices and the Division of Animal Health and Welfare. The Division of Animal Health and Welfare keeps in a central database all the information about the progress of the program. A committee of three Veterinary Officers examines and evaluates the new outbreaks, the depopulations or the declaration as free of the infected herds taking into account the laboratory results and the epidemiological reports for each case. The committee reports to the Director who takes the final decision and gives instructions to the District Veterinary Officers to take the required actions.

In every positive case the slaughterhouses and the dairy plants are informed.

The program is implemented in all the area controlled by the Veterinary Services of the Republic of Cyprus.

#### **4.4. Description of the measures of the programme<sup>8</sup>:**

##### **4.4.1. Notification of the disease:**

Brucellosis is a notifiable disease in Cyprus according to article 6 of the Law 109(I)2001. Any case of abortion or other symptoms related to brucellosis are compulsory notifiable to Veterinary Services of the Republic of Cyprus.

##### **4.4.2. Target animals and animal population:**

All bovine animals over 12 months old in breeding and production farms are involved in the programme.

##### **4.4.3. Identification of animals and registration of holdings:**

The central authority has registered all bovine herds in the Republic of Cyprus and each has been allocated a unique herd number in accordance with L.O. 338/2000 and 399/2002.

All bovine animals are ear tagged on both ears with an individual identification code in accordance with L.O. 508/2004 and EU Reg. 1760/2000.

A 10% of the establishments are randomly inspected according to Regulation 1760/2000.

##### **4.4.4. Qualifications of animals and herds<sup>9</sup>:**

The programme for the qualification of the herds is based on the following legislation: 64/432/EEC, L.O. 724/2003 and 160/2005.

##### **4.4.5. Rules on the movement of animals:**

All movements of animals should be reported and registered on a central database and are allowed only after a brucellosis negative serological examination.

Movements from infected herds are allowed after a special license and only for slaughtering in a certain slaughterhouse.

The central Database of the Animal Identification and Registration scheme enables tracing of any animal from the date of birth to the date of death or slaughter.

#### 4.4.6. Tests used and sampling schemes:

##### Serological tests:

Dairy Farms: Confirmation of a positive bulk milk ELISA test with Rose Bengal and Complement Fixation Test in all animals over 12 months old

Farms with less than 10 individuals over 12 months old: Screening test: Rose Bengal Test and confirmation with Complement Fixation Test

Infected farms: Monthly screening of all animals over 12 months with Rose Bengal Test and Complement Fixation Test.

##### Description of the used microbiological or virological tests:

Samples: Milk samples from seropositive animals of new outbreaks (centrifugation and sampling from the cream and deposit)

Aborted fetuses (gastric content and lung)

Isolation: On Brucella medium incubating in 37°C with and without CO<sub>2</sub>

##### Description of the other used tests: -

Dairy Farms: Screening test: bulk milk ELISA 4 times per year

All animals in not officially free herds are examined serologically every 12 months, while infected herds are under monthly reexaminations and slaughtering of the positive animals. In officially free herds animals are examined serologically once a year or are tested with bulk milk ELISA at least 3 times per year.

The programme for the qualification of the herds is based on the Directive 64/432/EBC.

#### 4.4.7. Vaccines used and vaccination schemes:

4.4.8. Information and assessment on bio-security measures management and infrastructure) in place in the holdings involved and

4.4.9. Measures in case of a positive result<sup>10</sup>:

After a serologically confirmed positive result, the committee evaluates the new case taking also into account the data from the epidemiological report and informs the Director who finally gives instructions to the District Veterinary Officers for measures to be taken.

- a. The farm is placed under movement restriction.
- b. The Organizations collecting the milk are notified to collect the milk from the infected farms in separate milk tanks for pasteurization.
- c. Seropositive bovines are isolated from the other animals to be slaughtered in the designated slaughterhouse. In case it is decided that all the animals in the herd will be slaughtered, restocking is permitted after 6 months.
- d. Seropositive animals are valued before slaughter. Compensations 100% of the reproductive value are paid to owners.
- e. Dogs or other species of animals susceptible to Brucellosis are also examined serologically.
- f. One month after the slaughter, all bovine over twelve months old are reexamined serologically.
- g. Serological reexamination of the confirmed positive herds is performed every month, and the seropositive bovines are culled.
- h. The owners clean and disinfect their farms under the supervision of the Veterinary Services, which provides the disinfectant free.
- i. The pasture is buried or collected and disinfected in a place far from establishments.

All the measures mentioned above are included in the following legislation:

2. The control of Brucellosis, Tuberculosis and Enzootic Leucosis of cattle orders of 2002 and 2003 (L.O. 14/2002 and L.O. 724/2003)
3. The animal health (requirements governing the trade in bovine and porcine animals), regulations of 2002 and 2005 (L.O. 464/2002 and L.O. 160/2005)
4. Directive 64/432 EEC.

#### 4.4.10. Compensation scheme for owners of slaughtered and killed animals:

The owners are compensated for the 100% of the reproductive value of the animals confiscated. These animals include those giving a positive result either to Rose Bengal or to CFT or to both of them or in case of depopulation all the animals of the flock.

#### 4.4.11. Control on the implementation of the programme and reporting:

The progress of the programme performed by the District Veterinary Offices is controlled by the Animal Health and Welfare Division, that is responsible for preparing the reports sent to EC.

### 5. Benefits of the programme<sup>11</sup>:

The costs for the authorities include the money and time spent for the implementation of the program (materials for sampling, testing, transportation of workers, salaries, compensations, transportation of the confiscated animals, disinfections) and also the risk of people working for the program to be infected with brucellosis. In addition, the inconvenience (movement restriction, milk and manure treatment, threat of transmitting the disease to neighbouring farms) that the program creates to the farmers, leads to conflicts with the authorities and other farmers and interferes with the regular application of the program.

However, the benefits for the farmers and society overcome any costs because the assurance of animal and public health through the implementation of the program is very crucial. The eradication of the disease on the long run will increase the productivity of farms concerning milk and meat quantity and quality. Also, farmers and their families will not be under the continuous threat of being infected themselves.
