





Application for lifting certain areas of Part III

Based on the Commission Delegated Regulation (EU) 2020/687 and African swine fever in the Union ('ASF guidelines') (C/2023/1504) of 18 December 2023:

- In the event of a single or limited ASF outbreaks clustered in space and in time (during a period of 30 days from the first outbreak in that zone) in establishments of kept porcine animals in a sufficiently large area with no ASF outbreak in kept porcine animals for the past 12 months – the three year or 12 months period referred to in point 6.1. can be reduced to 3 months';
- This criterion was implemented under official veterinary supervision by the SFVS.
- Passive surveillance system for establishments of kept porcine animals is implemented;
- Active and passive surveillance for wild porcine animals are implemented;
- No ASF outbreaks above mentioned territories were confirmed since 19 July 2024.
- No ticks of the genus *Ornithodoros* have been found in Lithuania.
