## REPORT OF THE SPS EXPERTS MEETING OF 25 FEBRUARY 2022 TO PREPARE THE WTO SANITARY AND PHYTOSANITARY COMMITTEE OF MARCH 2022

The meeting was convened to prepare the upcoming regular meeting of the WTO Committee on Sanitary and Phytosanitary measures (SPS Committee) that will take place virtually on **23-25 March 2022**.

## I. GENERAL ISSUES

COM informed the participants about the different events planned in the margins of the next SPS Committee meeting:

- 21 March next meeting of the Working Group on approval procedures
- 22 March before the formal committee meeting; Thematic Session on the trade facilitative approaches to pesticide MRLs, including substances not approved for use in an import market
- 23 March informal meeting, which will discuss the follow-up of the 5th review, the proposed SPS declaration for the 12th WTO ministerial conference, COVID issues and upcoming thematic sessions.

## **II. SPECIFIC ISSUES**

#### A. Issues of possible interest to third countries.

The issues raised by third countries at the previous SPS Committee meetings were discussed and an update was given by COM on those topics, which were likely to be raised at the next meeting.

#### **B.** Issues of interest to the EU

#### **B.1.** Possible specific trade concerns (STCs)

The issues raised by the EU at the previous SPS Committee meetings were discussed and an update was given by COM on those topics, which were likely to be raised at the next meeting.

#### **B.2.** Monitoring of the use of international standards

COM informed the Member States on cases of third countries trade restrictions not in line with existing international standards (ASF, HPAI) and outlined its planned actions to remedy the situation.

#### B.3. SPS Market Access Working Group (MAWG)

The next meeting of the SPS MAWG is scheduled for 7 April 2022 in a virtual format. COM outlined the proposed agenda and invited the participants to comment on it.

# B.4. SPS market access issues and possible bilateral meetings (in and outside Geneva)

COM informed MS about a number of SPS market access issues and its intention to request bilateral meetings in the margins of the next SPS Committee meeting and other upcoming meetings with third countries. To prepare the bilateral meetings with third countries, Member States were reminded to provide information on the latest developments on market access issues.
