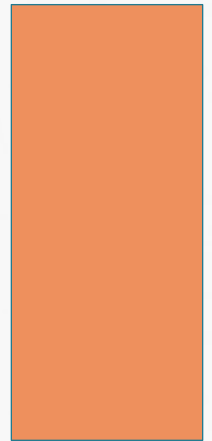

# ASF - EPIDEMIOLOGICAL SITUATION

## 01.01.2019 - 19.11.2019

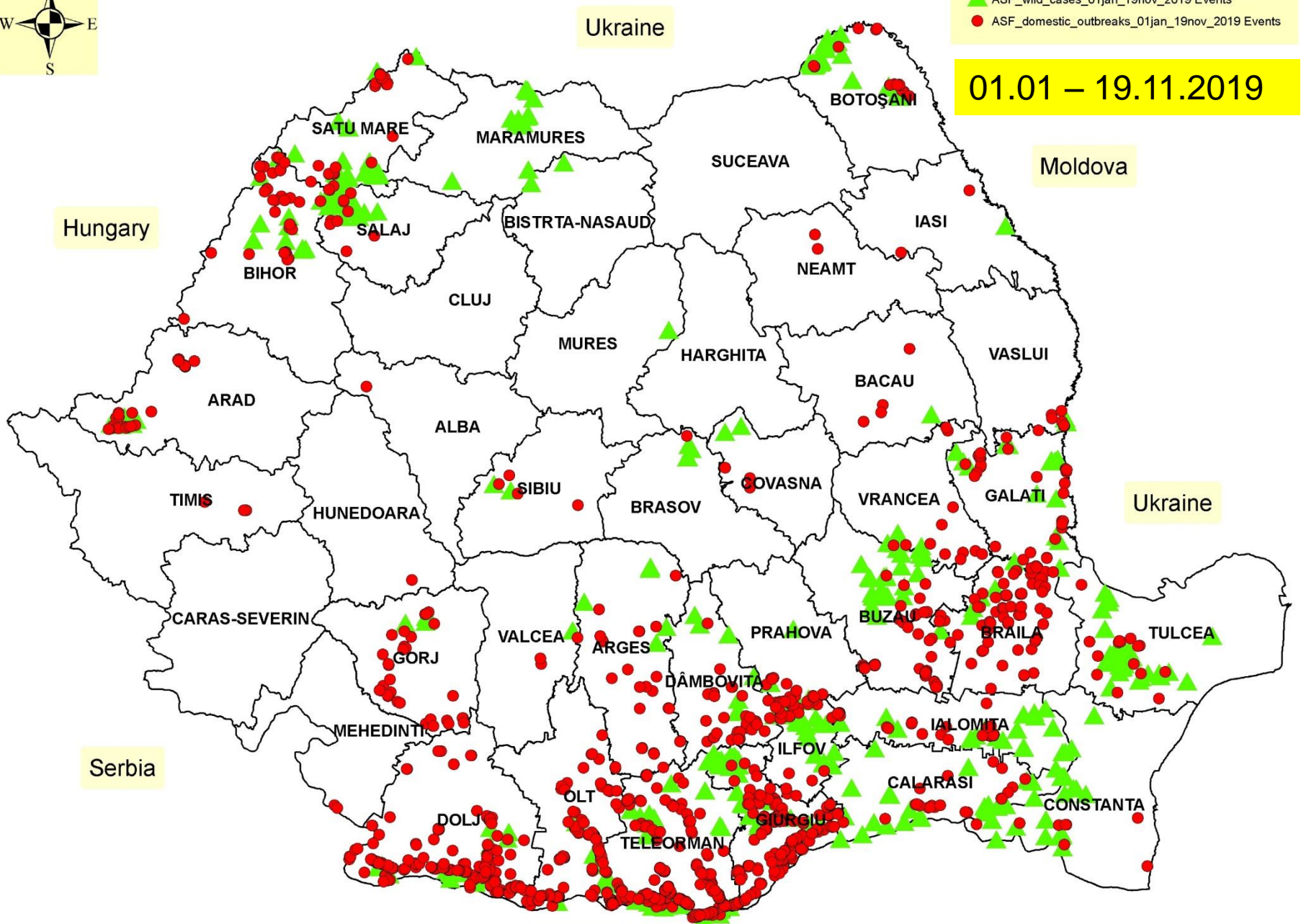
**Domestic pigs:** **1610** outbreaks with 144101 affected pigs from which, **30** infected commercial farms and **1580** infected backyards

**Wild boars:** **1711** positive cases, from which, **1292** found dead and **419** hunted wild boars

# CLOSED OUTBREAKS (01.01.2019 – 19.11.2019)

After all measures have been taken to ensure that no virus is circulating in protection and surveillance zones, restrictions for 817 outbreaks have been lifted.

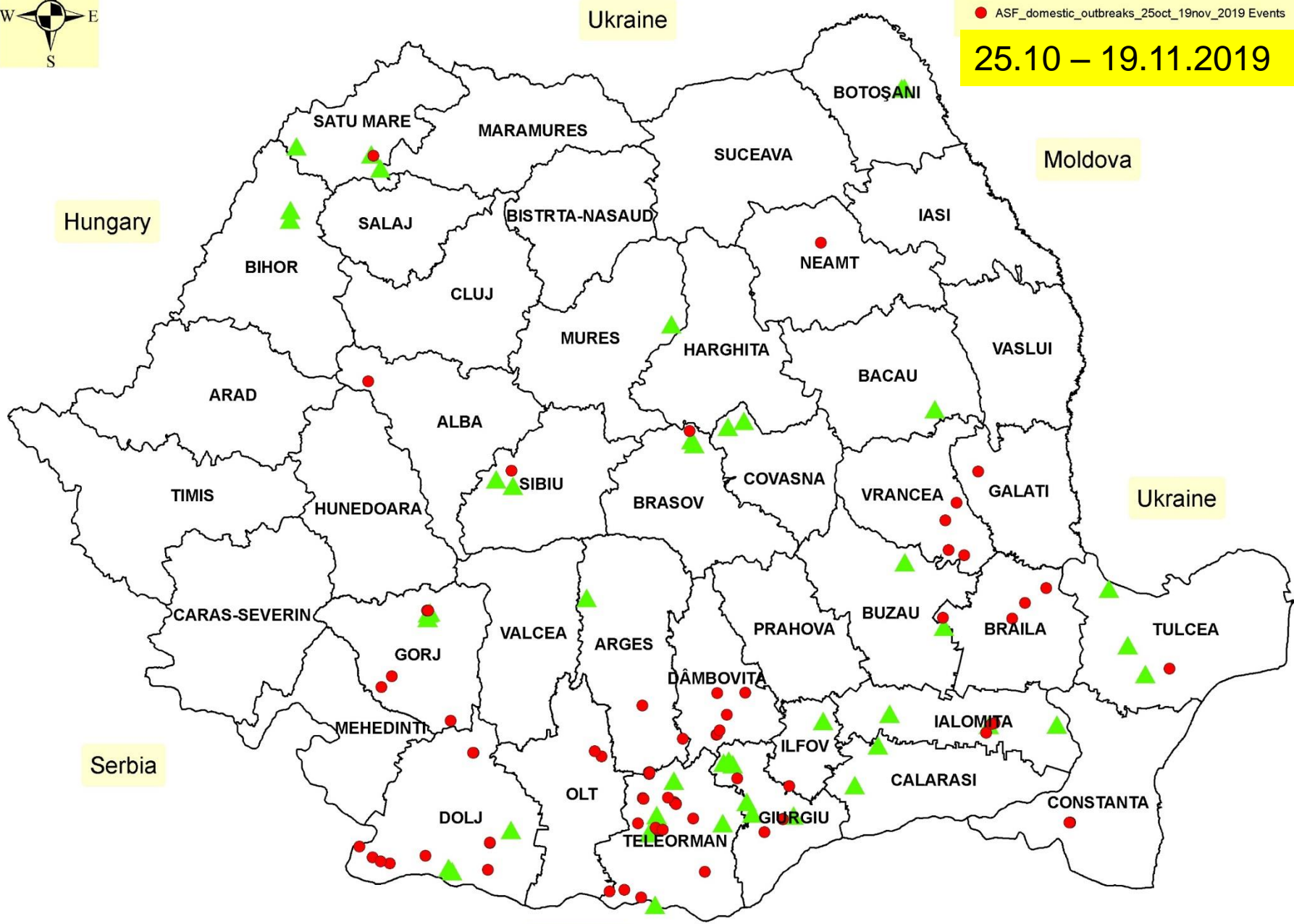

MEASURE	TARGET
Order for <b>establishing the sizing of pig farms</b> of Ministry of Agriculture and Rural Development in the territory of Romania	In force since 08.11.2019
Draft amendment of N.S.V.F.S.A. and Ministry of Agriculture and Rural Development Order regarding <b>biosecurity norms in pig holdings</b>	- <b>posted on NSVFSA website</b> , to ensure appropriate transparency - the legal deadline for sending comments is until 13.12.2019
Draft amendment of Government Decision for increasing the amount for the contravention fines	- <b>under approval by other institutions</b>

# RO ASF PLAN OF MEASURES (2)

MEASURE	TARGET
<p><b>National Disease Control Centre Decision nr.1/2019</b></p> <ul style="list-style-type: none"><li>-Portable <b>disinfection devices</b> are installed at the entrance and exit of markets, vegetable and fruit fairs</li><li>-<b>Pig raising is prohibited in isolated areas</b> like sheepfolds, forest cantons, etc.</li><li>-<b>Traffic controls</b> are being intensified. According with, these checks are carried out by joint teams of three institutions: IPJ (police), IJJ (gendarmes), and DSVSA (local veterinary authority).</li></ul>	-permanent
Instructions/ meetings / trainings with Local Competent Authority in order to improve the <b>epidemiological investigations</b> and to determine the source of the disease.	- permanent



# RO ASF PLAN OF MEASURES (3)

MEASURE	TARGET
Draft Government Decision to approve <b>measures for the surveillance, prevention and control of African swine fever among the wild boar population</b>	-in progress
<b>"Guide to good hunting practices and biosecurity during hunting"</b>	Posted on NSVFSA website. Was sent in the territory in order to inform and give instructions for hunting funds managers, hunters and other stakeholders.
<b>Inspections of holdings</b> in order to verify the animal health status and to update the National Data Base	- October – Decemer 2019 (in progress)

# RO ASF PLAN OF MEASURES (4)

MEASURE	TARGET
<p><b>Official Controls</b> on:</p> <ul style="list-style-type: none"><li>-identification of animals and registration of holdings</li><li>-holdings that represent a higher risk of spreading the ASF</li><li>-Traffic controls, movement restrictions</li></ul>	<p>- ongoing</p>

- Lifting Part III regionalisation and reverting to Part I for: Caraş Severin, Cluj and Harghita counties
- Lifting Part III regionalisation and reverting to Part II for Mureş county

\* The four counties were in Part I. Active surveillance is performed only if the carcasses are intended to be taken out of that area.

Considering:

- the effective prevention of the disease demonstrated by the surveillance of domestic pigs and wild boars,
- the epidemiological situation of the neighbouring counties,
- the surface of the four administrative unit,
- the main criteria for demarcating areas included in the Annex of Decision 2014/709/EU according to the Working Document SANTE/7112/2015/Rev.3,

Requires the inclusion of Harghita, Cluj, Caraş Severin county in Part I and Mureş county in Part II
