1. Technical implementation of the programme

1.1 Description and evaluation of the evolution of the epidemiological situation, the technical implementation of the activities foreseen under the programme and the cost-effectiveness of the programme.

In Slovakia, there was not confirmed any outbreak in the holding in the year 2019 and moreover was not confirmed circulation of BT - virus on the area of Slovakia. However, with the occurrence of disease in Hungary and Austria the whole territory of the Slovak republic fell in 2015 into restriction zone around the outbreaks that occurred in these countries. In 2018 Slovak republic applied to remove restriction zone from whole territory and the restriction zone was lifted on 30 April 2018.

1.2 Details on the level of achievement of the targets set in the approved programme and technical difficulties.

In 2019 the monitoring has been performed on 78 farms. These farms were selected on the whole territory of the Slovak Republic (in attachment) and on each of them 15 sentinel animals (cattle -sero- negative, non - vaccinated) from which the blood was taken once a month for serological examination in the vector activity period - (from mid may to mid December). the objectives set in the programs approved in 2019 were achieved. Within implementation of BT programe was not showed any technical difficulties
