

# Information on the results of the ASF eradication/surveillance programmes on 2016

SCOPAFF meeting, Bruxelles 18th - 19th September 2017



- Romania was free of ASF until 31-th July 2017 when the first outbreak was confirmed in domestic pigs in a non-commercial farms.
- Period of the developed surveillance, control and eradication programme is 2015-2016 but most probably it will be extended.
- Categories subjected to testing in 2016:
  - sick domestic pigs from non-commercial holdings with negative virological test for CSF
  - all sick or dead wild boars (all country) + all hunted wild boars in the 8 counties at risk,



Test used for passive surveillance was

PCR (Polimerase Chain Reaction), in order to detect the viral genome of ASFV, for domestic pigs and wild boars found dead or sick. **Tests used for active surveillance** 

- b. ELISA and PCR (Polimerase Chain Reaction), in order to detect antibody against ASFV, in hunted wild boars, in accordance with the provision of the Commission Decision 2003/422/EC approving the diagnostic manual for ASF.
- If a sample reacted positive at ELISA for antibody, a second test to be performed for disease confirmation: indirect immunofluorescence test (IIFT), Imunoperoxidase test (IPT) for antibody detection .
- The samples are tested at the National Reference Laboratory for ASF.





#### Other activities together with the survillance programme

•Enforcing the ASF strategy and the Contingency plan for ASF by a Governmend Decision which provides biosecurity measures in backyard farms and competences of the ministeries and governmental agencies in ASF prevention and eradication; this Decision also provides that the winter feeding will be reduced to avoid the increase of wild boar population and density;

•Raising the awareness in the counties found at risk, by spreading leaflets and press releases;

•Banning the fairs and markets for pigs in the 8 counties found at risk on the N-E borders with Ukraine and Republic of Moldova;

•Intensify the clinical surveillance in domestic pigs and wild boars;

•Intensify the control of passengers luggage at borders to not introduce pork products and confiscated the products found: <u>4108 kg in 2016</u>



Cost of the programme

- Total cost for Romania: 106.978 EURO
- Cofinanced by the EU: 94.032 EURO
