C.01 Exchange of views of the Committee on a draft Commission Implementing Regulation laying down rules for the application of Regulation (EU) 2016/429 of the European Parliament and of the Council with regard to the approval of germinal product establishments, traceability and animal health requirements for movements within the Union of germinal products of certain kept terrestrial animals. (EC)

The proposed Regulation will establish rules for the uniform implementation of the requirements set out in Regulation (EU) 2016/429 in relation to the provision of information by operators in their application for approval of their germinal product establishments for bovine, porcine, ovine, caprine and equine animals and the time-limits for providing that information, to the technical requirements and specifications for marking of germinal products and operational requirements for their traceability, and to the provision of information by operators on movements of consignments of germinal products and notification of those movements.
