




ASF in Slovakia – the development of the sitation in the period from the last Paff committee meeting

• Till 23.9. 2019 : 11 outbreaks, 12 positive WB


- From 23.9.2019 till 21.10.2019 : 8 WB confirmed
- No further ASF outbreaks in domestic pigs
- All WB confirmed within established part III area (CID 2019/1373)districts Michalovce/Trebišov

Domestic pigs -measures still in place

- "ban of breeding of pigs in villages where positive cases have been confirmed –
- domestic slaughter activities in Trebišov district- organs samples taken – following ASF diagnostics manual
- reporting obligations of all dead and sick pigs as well as domestic pigs slaughtered to the locals authorities



















Geographical distribution of samples submitted for ASFV investigation in domestic swine in Slovakia during 2019 (January - 15 October)





Measures in place – hunting grounds I.

Active search of dead wild boar carcasses in the hunting ground. /Prohibition of rearing wild boars in the game reserves for wild boar game.

- Carrying out hunting wild boar game only on an individual bass
- Prohibition of hunting all hoofed game and small game, excluding hunting migrating wild ducks and common hunts of hoofed game in the game reserves.
- Immediately inform competent DVFA of found dead wild boar game and live wild boar game suspected of being infected by ASF.
- Using hunting dogs only for the purpose of searching carcasses of dead wild boars.
- Prohibition of performing testing of hunting dogs in which working out in the hunting ground is required.
- Disposal of dead wild boar game and animal-by products made of hunted game. Carcasses or remnants of dead wild boars, animal-by products from the hunted wild boars must be safely removed by disposal in the processing plant (rendering plant). Burial on site is possible only in exceptional cases approved by the competenent DVFA. Transport of dead wild boars packed in impermeable packagings to the place of safe storage in the container
- Storage of carcasses of dead wild boars at the safe places, notified to DVFA, in the containers up to the time of safe transport to the rendering plant. Each peace must be sampled and subsequently investigated in the laboratory on ASF
- Dead wild boars and animal-by products must not come into contact with the pigs in the farm. Persons envolved in hunting and manipulation with hunted or dead wild boars must not come into contact with pigs in the farm minimum 48 hours after manipulation. Immediately after completing manipulation, used clothes must be washed, footwear and tools cleaned and disinfected.
- Measures for taking and submitting samples for investigation of all hunted wild game and found dead wild boar game must be
 followed. As dead game is considered all game killed other than by hunting (e.g. killed by means of transport, big predator,
 etc.). It is necessary to deliver the sample of dead wild boar game to DVFA within 24 hours from finding the cadaver, or at least
 on the following working day.
- Sampling must be carried out by the persons trained for examination of wild game after hunting on site, or persons trained for sampling CSF by the District Veterinary and Food Administration. /Sampling of dead wild boars directly in the hunting ground or in the rendering plant. If the sample is taken in the rendering plant, identity of the wild boar carcass must be ensured by means of tag for marking hunted hoofed game.
- Keep consistent evidence of each dead /hunted wild boar by the user of the hunting ground.






- Means of transport/place of finding /place of hunting must be disinfected by the disinfectant effective against the ASF virus after finishing manipualtion.
- Keep hunted wild boars in the cooling box, carry out sampling for laboratory investigation. Further manipulation with the wild boar carcasses is possible only after receiving negative result of examination of all wild boar carcasses stored together in the box
- Safe disposal of all hunted wild boar carcasses stored together in the box, in the rendering plant if only 1 piece is positively tested on ASF.
- Prohibition of common storage of other hunted hoofed game intended for domestic market with animal-by products from wild boars.
- Prohibition of moving live wild boars outside the infected area
- Prohibition of moving wild boar meat that is not heat treated, products made of not heat treated wild boar meat and trophies of wild boars out of the infected area
- Monthly submit reports on hunting and death of wild boar game to the competent District Office Land and Forest Department, according to their guidance. The report can be substituted by keeping evidence in the POĽOVSTAT programme

Movements restrictions still in place



Ordered in acordance with 2014/709/EC

- 1. designation of slaughterhouses for pigs originated from part III area (whole procedure) reported to the EC
- 2. Movement restrictions in place and ordered by Chief Veterinary Officer
- 3. Placing on the market for WB originated from part I- no derogation from the prohibition yet (lab. investigaion obligatory)






Geographical distribution of samples submitted for ASFV investigation in wild boars in Slovakia during 2019 (January - 15 October) - active surveillance












Geographical distribution of wild boars samples positive for ASF virus in Slovakia during 2019 (January - 15 October)



Geographical distribution of samples submitted for ASFV investigation in wild boars in Slovakia during 2019 (January - 15 October) - active surveillance - selected districts





Geographical distribution of samples submitted for ASFV investigation in wild boars in Slovakia during 2019 (January - 15 October) - passive surveillance - selected districts

Benefits for hunters -2019asn update


 10 € to the user of the hunting ground - for sampling and delivering samples (hunted wild boars in the buffer zones






- 40 € to the user of the hunting ground for sampling and delivering samples (perished wild boars on the whole territory)
- 50 € in the selected HGs to promote active searching dead WB (in the HG where hunting is prohibited)
- 30 € to the user of the hunting ground for selective hunting of female wild boars (hunted wild boars on the whole territory)




SK zoning- October 2019







Laboratory Investigations of ASF in wild boars in Slovakia during 2019 (January - 15 October) - active surveillance - district Košice okolie






Laboratory Investigations of ASF in wild boars in Slovakia during 2019 (January - 15 October) - passive surveillance - district Košice okolie

Conclusions



- 11 outbreaks (backyards) and 19 positive WB confirmed (till 20.10.2019)
- Still localised in the area south/east next to HU border
- Measures in accordance with EC/SK legislation adopted
- The movements restrictions in accordance with 2014/178/EC applied
- Eradication programme- will be sent to the EC in November 2019
