The proposed Regulation intends to authorise the re-entry into the Union from a new zone CN-3 of registered horses originating from the Union after the temporary export. The zone CN-3 is established for a temporary period in order to host the equestrian events in Hangzhou, China (the 19th Asian Games) and to allow registered horses originating from the Union to return to the Union after taking part in those events.
