- year 2023: 438 ADIS reports (up to 15.06.2023)
- Curteently -First update enlargement of the part II area from beggining of February 2023
- Last outbreak in domestic pigs confirmed in July 2022 (almost one year without ASF in domestic pigs)
- For the actual PAFF meeting:
- A) the request to withdraw one area from part III and to revert it into part II
- B) to provide some areas -<u>updates in part II</u> (part I accordingly Žarnovica/levice area)







- the outbreaks successfully depopulated
- without any ASF outbreak for almost 12 months
- Final cleansing and disinfection of outbreaks done: 11.8.2022
- Lifting of disease control measures in the affected establishment done:
 14.9.2022
- holding destroyed -without animals till now, no repopulation





SK summary ASF – June 2023 – summary

- ASF positive results in wild boar population
- Increase in the number of virologically negative versus serologically positive (WB)
- No ASF in domestic swine (no suspicion for the time being)
- the presence of infected wild boars near farms increases the likelihood of the virus entering domestic pig farms
- The improtant fo follow by FBO /hunters the prescirbed measurs in both domestic puigs and WB (WB management)
- The situation of item no. in domestic pigs there is no circulation of the virus
- Using the possibility of reducing the density of wild boars by sanitary shooting
- Removal of dead carcasses from the environment preffered practicee in Slovakia –it reduces the cycle of transmission of the virus surviving in the body of dead wild boars to the susceptible living population
- An audit ASF DG SANTE just started (20.6-4.7.2023)
