**Amending the Unified Veterinary
(Veterinary-Sanitary) Requirements for Goods
subject to Veterinary Control (Surveillance)**

In accordance with Paragraph 2 of Article 58 of the Treaty on the Eurasian Economic Union of 29 May 2014 and Paragraph 22 of Annex 2 to the Rules of Procedure of the Eurasian Economic Commission approved by Decision No 98 of the Supreme Eurasian Economic Council of 23 December 2014, the Board of the Eurasian Economic Commission **has decided:**

To amend Section II of Annex 1 to the Unified Veterinary (Veterinary-Sanitary) Requirements for Goods subject to Veterinary Control (Surveillance) approved by Decision No 317 of the Commission of the Customs Union of 18 June 2010, as set out in the Annex.

This Decision shall enter into force on the 30th calendar day following its official publication, but not before the entry into force of the Decision of the Council of the Eurasian Economic Commission amending the Unified List of Goods

subject to Veterinary Controls (Surveillance) by adding to the list of goods such items as leguminous vegetables and feed additives.

AMENDMENTS
to Section II of Annex 1 to the Unified Veterinary (Veterinary-Sanitary)
Requirements for Goods subject to Veterinary Control (Surveillance)

1. The text in item 39, column 6, shall read as follows: 'Not subject to inclusion in Register, but import permit and veterinary certificate shall include the number and (or) name of the undertaking that placed on the market the goods subject to control'.

2. After item 46, include the following item:

'46 ¹	from 0708, from 0713	Leguminous vegetables for use in animal feed ⁵	Veterinary certificate	Yes	Not subject to inclusion in Register, but import permit and veterinary certificate shall include the number and (or) name of the undertaking that placed on the market the goods subject to control.'

3. After item 68, include the following item:

4. The text in item 94, column 6, shall read as follows: 'Not subject to inclusion in Register, but import permit and veterinary certificate shall include the number and (or) name of the undertaking that placed on the

market the goods subject to control.'

5. The text in item 95, column 4, shall read as follows: 'Veterinary certificate for goods containing components of animal origin and goods for veterinary use, including for animal feed.'
