#### 1. Technical implementation of the programme

# **1.1** Description and evaluation of the evolution of the epidemiological situation, the technical implementation of the activities foreseen under the programme and the cost-effectiveness of the programme.

In accordance to EU Directives 999/2001/EC and 1041/2006 screening for TSE's has been carried out since March 2001,

The objective of the programme included:

- Achieving harmonization with other EU countries in veterinary control and surveillance programmes;
- The strengthening of veterinary epidemiological surveillance measures in accordance with EU legislation;
- Ensuring the early recognition of TSEs within the local animal population;
- The rapid implementation of investigation protocols with all relevant restrictions on the movement of animals and animal products coming into force until confirmatory results are received.

Brain samples for BSE testing have been taken from all bovines of the following groups:

- bovines exhibiting clinical signs of neurological disease
- dead animals over the 48 months of age
- emergency slaughtered animals over 48 months of age
- animals over 48 months of age with clinical signs at ante-mortem

The objectives of the programme in small ruminants were:

a. To implement a TSE monitoring and surveillance programme as laid down in Reg. (EC) 999/2001

b. To identify the presence scrapie infected animals in the national flocks

At least 100 healthy slaughtered ovines and 100 healthy slaughtered caprines had to be sampled at slaughter.

At least 100 dead ovines and 100 dead caprines will be sampled. These animals had to be sampled at the central carcass disposal centre.

# **1.2** Details on the level of achievement of the targets set in the approved programme and technical difficulties.

In regards of the cattle during 2019 over 200 bovines have been tested amongst two risk animal categories (fallen and emergency slaughtered). Bovines with clinical signs of neurologic disease referable to TSE syntomotaloghy were not notified in the considered period.

In the same time the targets of 100 animals (healthy slaughtered and fallen) for ovine and caprine species were widely exceeded.

No sample tested had a positive result.

The surveillance programmes are applied to the Islands of Malta and Gozo (one region);

There is a lack of grazing land available so livestock is reared on farms having a higher stocking density than would apply to an extensive system with an average farm size around 0.5 hectares.

The map attached shows the distribution of cattle farms on the Maltese Islands and in no one of all farms was detected a TSE case so far.
