4. Adoption of minutes of the previous Sub-Committee meeting

5. Discussion of a draft report on "The use of fish by-products in aquaculture"

The Chairman of the Working Group, Dr. Michael Gunn presented the draft report, which was discussed in detail by the Sub-Committee members. Various amendments and clarifications were suggested and the document will be revised accordingly and re-discussed at the next Sub-Committee meeting. Sub-Committee members also commented upon a draft opinion prepared by the TSE/BSE *ad hoc* group of the Scientific Steering Committee on "The feeding of wild fishmeal to farmed fish and recycling of fish, with regard to the risk of TSE".

6. Miscellaneous

Sub-Committee members were updated on the progress of two other working groups, one considering recent diagnostic techniques for some OIE "List A" diseases and the other dealing with improved vaccines for the same OIE "List A" diseases. A draft document may be tabled for discussion at the next Sub-Committee meeting, which accordingly could be extended to a two-day meeting.
