**B.01** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision on the evolution of animal diseases in Third Countries.

**B.02** Exchange of views and possible opinion of the Committee on a draft Commission Implementing Decision amending Decision 93/195/EEC as regards animal health and veterinary certification conditions for the re-entry of registered horses for racing, competition and cultural events after temporary export to Mexico and the United States of America, and amending Annex I to Decision 2004/211/EC as regards the entry for Mexico in the list of third countries and parts thereof from which imports into the Union of live equidae and semen, ova and embryos of the equine species are authorised. (RS)

Equestrian events will take place in Miami, USA, from 7 to 9 April 2016, and in Mexico-City, Mexico, from 15 to 17 April 2016. Given the epidemiological situation, re-entry after temporary export of registered horses for competition and cultural events from Mexico is currently not authorised. However, it is possible and appropriate to lay down specific animal health and veterinary certification conditions for the re-entry of horses mentioned above.
