



ASF in Lithuania in wild boars in 2023




● 254 hunted wild boar




Restricted zone I needs to be reverted to restricted zone II:


1 dead wild boar (found in the river) – tested positive to ASF

The Neringa region located in the Baltic Sea (water barrier). A peninsula with sand dunes separating the Curonian Lagoon from the Baltic Sea.


16 outbreaks in DP establishments in 2022

- **3** commercial (2202 pigs).


3 outbreaks in DP establishments in 2023

No ASF outbreaks in domestic pigs since July 2023




ASF in Lithuania in domestic pigs in 2023




In 2023 in Restriction zone II confirmed 3 ASF outbreaks





Application for lifting certain areas from Part III and revert to PART II



Based on the Commission Delegated Regulation (EU) 2020/687 and according to Commission working document No. SANTE/7112/2015:

- At least 12 months after the disinfection of the infected establishments are past;
- Clinical examinations are carried out;
- Passive surveillance system for establishments of kept porcine animals is implemented;
- Active and passive surveillance for wild porcine animals are implemented.
